Description

This course introduces the main problems of Indo-European nominal inflection and derivation, with a focus on accent and ablaut classes, the case system and “decasative” derivation, external and internal derivation, composition, and the relationship between collective and feminine. As these are among the hottest topics in Indo-European linguistics today, the course aims to bring students fully up to date with the latest research in the field. To this end, we will read some of the classics of modern Indo-European scholarship, including selected articles by Schindler and Nussbaum, as well as brand-new contributions from older and younger scholars.

Requirements

Class attendance and preparation are of course required. Most readings will be in English, but a few papers in German and French have also been included; you are strongly encouraged to at least try to read them in the original. In addition, you are to select a topic with my approval and write a research paper of approximately 5-7 pages, evaluating the scholarly literature and describing the current state of knowledge and opinion.
